Assignor Fees

- A. This fee will be paid upon receipt of schedule confirmation dates and an invoice from the officials' chapter. Fees will be made payable to the organization as per Board policy.
- B. Failure to provide payment or verification of payment as requested shall result in the rescission of official assignments until payment is made.

Contract Re-Opener

The parties agree to a potential "re-opener" in contract in year three whereby economic conditions or other factors result in either party requesting to re-open. The date to re-open will be no later than 9/1/2025 and any adjustment shall not exceed (+/-) 6% or previously agreed game fees.

Scrimmages

- 1A. Scrimmage fees will equal a sub-varsity fee per official, per level for all three years.
- B. The number of officials to be paid will be equal to the number of officials that would work a regular season contest. If additional officials are assigned, the total fee will be split among them, unless a caet is assigned to

work the contest also. If only one official is present, he/she will be paid the contracted varsity game rate.

- C. Scrimmage length will be one official game time (80 minutes). Any additional time will be paid at a rate of \$26.00 per official per half hour.

Site Management

1. The host school will have a site manager for each contest and be available to the officials to address any spectator issues or safety concerns when requested. The site manager shall make sure vouchers are provided or identity of officials are confirmed for electronic payment prior to conclusion of the game. It is recommended that the site manager be present to proactively address and spectator misbehavior and escort officials if requested by officials off fields.

Regular Season

- 1. Sub-varsity contests will consist of 35 minute halves unless otherwise agreed upon by the Athletic Director or his designee.
- 2. Any fees for special meets, tournaments, or championship competition will be mutually agreed upon by individual leagues and/or the meet director of such competition and officials groups.
- 4. It is strongly recommended the organization shall provide the contact number of an individual[s] with the authority to resolve assigning issues during the assigned contest. Assignors information will be made available to a school including email and cell phone contact number. Cell phone numbers of athletic directors will also be made available.
- 5A. Written or electronic confirmation of assignment dates and times for all scrimmages and games shall be received by the school at least 2 weeks prior to the start of the season. If individual names are required schools will contact the assignor for details.
- B. All Officials' chapters will use a computer web based assigning program as per NJSIAA recommendation. The contact information for all officials will be posted on site.
- 6. The assignor will notify the Director of Athletics and / or school administrator 24 hours in advance (if possible) if a game/meet cannot be covered.
- 7. The assigned officials will be required to contact the home school by 2:00pm the day of activity for confirmation. Contact should be made the day before for weekend/holiday contests. If no contact is initiated and the contest cancelled, no fee will be due.
- 8. Due to circumstances beyond the control of the home school, a ½ game fee

will be paid where an official shows up for a game and the contest is never started. If a school has failed to notify an official of a cancellation, a full fee will be paid. Once a contest is started, a full fee will be paid.

9. The assignor shall be notified by the home school of any cancellations three hours prior to game time. Emergency or weather related issues are exceptions to this – a lack of transportation notified that late is not an exception. If an official appears on site for a contest under this umbrella a full fee will be paid to the official for the contest. When an official is notified less than 90 minutes prior to game time for a cancelled game – a half game fee will be paid if the official is not moved to another contest that day. If the official shows up on site – then a full game fee is due.

10. Officials organizations will make every effort to cover all games with a full complement of officials. Organizations unable to do this consistently should meet with involved conferences to resolve the problem. Schools should be informed 3 hours prior to game time if a full compliment of officials will not be available.

11. Conferences will make every effort to coordinate schedules and present a balanced schedule to officials organization. It is recommended that a school send in the conference base schedule by May 1st to the assignor, and complete schedule by June 15th preceding season.

12. If a school is notified prior to start of the varsity contest that there is a shortage of officials for that day a full contracted fee (1 ½) will be paid to the official who works the contest alone (or if an official works alone due to extenuating circumstances).

13. As per the N.J.S.I.A.A. Constitution/By laws, when only (1) official arrives for a game to which (2) officials are assigned, the game must be played. The same applies when an official is unable to complete the assignment.

14. All games must be in ZebraWeb to be played that day on a site. Any changes must be confirmed by assignor and approved before any additional game times may be played.

15. As per NJSIAA, all schools shall be assigned equitably regardless of method of payment (i.e., cash, voucher, Ref. pay etc.)
